## The 3<sup>rd</sup> Sino-European Life Science Forum



The 1st and 2nd Sino-European Life Science Forum was held in 2015 (Ningbo, Shaoxing, Shenzhen and Zhongshan) and 2016 (Hangzhou & Nanjing) respectively. The Forums have successfully supported 35 European experts/times to bring 35 high quality projects within 4 major sub-sections, and conducted efficient communications with Chinese counterparts through project presentation, road-show, match-making, company visit etc. Both the Chinese and European delegates have been highly positive to the achievement made, which results in 1300 match-making meetings with an average of 37 meetings/expert, and 24 intended collaborations.

Based on such success, PCPAE and CAST decided to hold the 3rd Sino-European Life Science Forum from November 15, 2017 to November 24, 2017 at Chendu, Zhangjiang and Haikou.

The main theme for the 3rd Sino-European Life Science Forum is: China Europe life science innovation, exchange and cooperation.

**Projects requirements:**

1. Project owner should be either European life science researchers, entrepreneurs, or representatives from European research institutes and companies
2. Projects should be innovative in specific area; early-stage projects should have a clear industrial and commercial prospective; industrial projects should have an advanced technological edge.
3. Project associated Intellectual Property (IP) must be without any conflict of interest; project owners either own the IP or have authorization from the IP owners.

**Project areas of interest:**

We are calling for innovative projects from Europe in the following areas:

1. New drug R&D (cancer, diabetes, cardiovascular, Alzheimer's Disease, Herbal medicines and biologics, etc.)
2. Innovative therapeutics (gene technology, precise therapeutic treatment, nano technology, immuno-therapy, medical imaging, medical recovery technology, etc.)
3. Med-tech (Non-invasive and minimal invasive medical treatment technology, 3D printing, biomaterials, diagnostics, bio-medical, e-health etc.)
4. IVD diagnostic products and platforms
5. Life science in silver economy
6. Medical cosmetics
7. Life science applications for innovative new city development
8. Others

Application and registration:

1. Company project should be properly described in the Application Form (see attachment).
2. Only those projects that have been screened and approved by Expert Committee and the Chinese local partners will be invited to participate the Forum
3. No registration fee for participating the Forum upon official invitation
4. Application schedule:
  - a. Application deadline: July 31, 2017
  - b. Expert Committee reviews: August 10, 2017
  - c. China reviews (Central & local partners): August 31, 2017
  - d. Final invitation release: September 10, 2017
