- ✓ Project associated Intellectual Property (IP) must be **without** any conflict of interest; project owners either own the IP or have authorization from the IP owners. The organizers shall have no obligation for checking the IP ownership and shall assume no liability on any IP dispute.

- ✓ Med-tech (Non-invasive and minimal invasive medical treatment technology, 3D printing, biomaterials, diagnostics, bio-medical, e-health etc.)
- ✓ POCT and IVD diagnostic products and technical platforms
- ✓ Aging well and silver economy (diagnosis, prevention and treatment in elderly adults, services for adults with intellectual and developmental disabilities, elderly nutrition etc.)

 - ✓ Application deadline: March 20, 2019
 - ✓ Expert Committee reviews & China reviews (Central & local partners): April 15, 2019
 - ✓ Final invitation release: April 20, 2019
5. Traveling and accommodation compensation:
 - ✓ The international/domestic traveling costs for invited project representative will be compensated (6000 RMB/person)
 - ✓ The local travel and accommodation costs during the Forum period will be covered by the local meeting organizer.
 - ✓ The invited participants should join the entire forum program and follow the agenda set by the forum. In case of early departure from the forum, the travel and accommodation compensation shall be cancelled.
 - ✓ The participants shall be responsible for his/her own travel insurance.
